Lectures (MH1, MH 2 as interactive lectures and visualizations) provide students with materials (visuals, in the form of videos, using multimedia technologies), which is the basis for independent and classroom training of higher education, also apply knowledge and understanding of the subject area (learning outcome PH 1). The lectures are complemented by workshops (case study MH3) and seminar classes (MH5) that give students the ability to use basic categories and the latest theories, concepts in the field of the EU law and policy (learning outcomes PH 2 and PH 3). The use of the debates (MH4) and case methods (MH3) provides students with problem-oriented thinking and management decision-making skills based on the analysis of complex real-life situations, identification of problems and opportunities, the analysis of alternatives and the choice of the best ones (PH 3, PH 4).

The ability to carry out effective communications and resolve situations in professional activities is developed within H $\upmu$  3-5, by MH 3-5. The ability to identify, pose and solve problems is developed within H $\upmu$  1-5, by MH 3-5. Students will also develop critical and analytical thinking, and ability to work in the international environment during H $\upmu$  1-5 by MH 1-5.
